I also understand that I may be required to provide identifying information (e.g. social security number, address and date of birth) when making inquiries about my account. I understand that upon enrollment I will be issued a DEBIT Card for HSA for use with my account. I understand that I am responsible fo determining if an expense is an eligible medical expense and maintaining proper documentation for tax reporting and potential audit purposes.
I understand that I am establishing an HSA with First National Bank of Ottawa, in conjunction with Medical coverage through Blue Cross Blue Shield of Illinois. Funds are FDIC insured by First National Bank of Ottawa up to the legal limits allowed.
