# BOH Report MAY 2024

- The Health Department welcome 2 new staff members in April. The Department now currently has three (3) positions open
  - Environmental Health Practitioner - pending
  - Public Health Nurse/Program Specialist for WIC
  - Public Health Nurse (Immunizations)
- Over the last month or so the Health Department has continued to field calls regarding Botulism-like symptoms experienced in two county residents. As of mid April, the CDC had received reports of 19 people in 9 states who experienced harmful reactions after receiving counterfeit botulinum toxin injections (commonly known as “botox”) or injections administered by unlicensed or untrained individuals and/or in non-healthcare settings, such as homes or spas. Nine people were hospitalized and four were treated with botulism antitoxin because symptoms were consistent with possible spread of toxin. No deaths have been reported.
- Staff continue to participate in conference calls regarding Highly Pathogenic Avian Flu/H5N1 and its spread to dairy cows and its potential to spread to humans. The Department was asked to verify its current “on hand” stock of Personal Protective Equipment in case it was needed to be dispersed to dairy farms in the county.
- The Health Department reported its first West Nile Virus activity in May. A Robin from the Somonauk Area tested positive for the virus. Environmental Health Staff have also started their annual Mosquitos surveillance.
- Healthier LaSalle County held their kick off meeting for the Community Health Needs Assessment. As we did in 2022, the Health Department will be participating with OSF and our



community partners. Data collected from the survey will be used for our future IPLAN required by IDPH for our Department's Certification.

- Staff will be participating in a Perfectly Flawed Resource Network. These meetings will meet quarterly and connect multiple agencies across the region focusing on the harm reduction and substance mis-use.
- Our Department met with the regional Office of Educational to discuss the potential of bringing the Who We Play For program to local high schools this fall. Who We Play For is an organization that brings heart screenings to local communities for young athletes in an effort to eliminate preventable sudden cardiac death in the young through affordable heart screenings. WWPF aims to inspire and empower schools, sports clubs, and communities to provide heart screenings for every student-athlete, and student; no matter their level of athletics, socio-economic status, or geographical location. They represent every young person who lost their life to Sudden Cardiac Arrest. Their fight is to ensure that other families, teams, and communities will never know that pain.
- Staff recognized June 7<sup>th</sup> as National Wear Orange Day in honor of Gun Safety Month. Why Orange? Hunters wear orange to keep them safe, and so orange has been chosen as the color to keep everyone safe, and to highlight efforts to decrease gun violence.

## **ROE Report**

**August 2024**

**Chris Pozzi, LEHP, CPHA**

- Ms. Pozzi reported that they welcomed two new staff to our Department.
- The Health Department has one (1) positions open
  - Public Health Nurse (Immunizations)
- Ms. Pozzi reported that on July 9<sup>th</sup>, our management team attended a Building Your Team training sponsored by LaSalle County Human Resources.
- Ms. Pozzi reported that on July 10<sup>th</sup>, she participated in an Illinois Retail Food Sub-Committee meeting.
- Ms. Pozzi reported that on July 12<sup>th</sup>, Environmental Health has completed their IDPH Food Program review. Based on the final interview, no deficiencies were noted.
- Ms. Pozzi reported that on July 17<sup>th</sup>, she participated in an Illinois Association of Public Health Administrators Executive Board Meeting.
- Ms. Pozzi reported that on July 23<sup>rd</sup>, she attended a Regional Illinois Association of Public Health Administrators Meeting.
- Ms. Pozzi reported that Personal Health staff have completed orientation for the Lead Program. Once the grant opens up we anticipate offering childhood blood lead level screenings at the Department as well as case management for children with elevated blood lead levels. At this time the Department is not planning to “take on” the environmental inspection portion of the grant. Environmental Lead Housing Inspections will continue to be conducted by IDPH.

- Ms. Pozzi reported that completed moving of historic vaccination records to the LaSalle County Nursing Home Storage room. These records had been previously stored at the LaSalle County Complex for many years in a secure area. It was recently brought to our attention that the room they were stored in was no longer locked and the files were not secure. Due to Maintenance Department staffing shortages this summer and the immediate need of securing these records, we hired a moving company to transport the files to our locked record room at the LaSalle County Nursing Home.
- Ms. Pozzi reported that staff SIPA retention bonuses were paid out to staff members who had completed their probationary period.
- Ms. Pozzi reported that staff are continuing to monitor the status of H5N1 across the county. CDC Surveillance Statistics as of August 14, 2024.

- Ms. Pozzi reported that IDPH had notified the Department in late June about a wastewater surveillance sample from April that showed the presence of H5 influenza. Further testing is required to determine if this was H5N1 influenza. Staff did consult with IDPH

about potential outside sources of H5 in the wastewater stream.  
NO additional updates have been provided.

- Ms. Pozzi reported that the switch to VOYCE interpreter services for the Department is going well. In our first full month of usage in July, we logged 943 minutes of translation services- 681 minutes of Audio services and 262 of Video translation. These services cost us \$639.15 an approximate saving of \$860.22 this month alone compared to our previous vendor.
- Ms. Pozzi reported that we have finally received our Comprehensive Health Protection Grant application from IDPH. This grant covers several of our core programs – Local Health Protection which includes Food, Sewage, Water, and Communicable Disease, as well as the Tanning, Body Art, Safe Drinking Water, Tick Surveillance, Vector, and Peri Natal Hep B programs. We are also adding on the lead screening program this year. Two new grants are included this year – Tuberculosis (TB) Prevention and Opioid Overdose Prevention. We will be submitting plans for these grants as well.
- Ms. Pozzi reported that staff have been busy providing back to school immunizations for students.
- Ms. Pozzi reported that staff have been busy inspecting summer food festivals throughout the County.
- Ms. Pozzi reported that staff have attended multiple Health Fairs this month including Touch a Truck in Ottawa on July 28<sup>th</sup>, the National Night Out held at Riordan Pool on August 6<sup>th</sup>, and Central School's Back to School Night on August 19<sup>th</sup>.
- Ms. Pozzi reported that she attended IAPHA's general meeting on August 15<sup>th</sup>.
