## New Teacher Orientation

Each year in early August, the Regional Office of Education sponsors a New Teacher Orientation Seminar for educators new to teaching or new to our region. Presentations included legal updates from Attorney Walt Zukowski and Sara Swartz, SEL Specialist, with information on resilience and self care. Information was provided regarding licensure and renewal laws, ISBE legal updates, compliance issues, regulatory issues, and school improvement. A total of 39 teachers attended the event on August 2, 2023.




## School Bus Education 223 Training Courses



School bus drivers in Illinois must complete an initial training course (first-time drivers) or a refresher course (renewals) prior to driving a school bus for Illinois schools. The LaSalle, Marshall & Putnam Regional Office of Education provides this training on a yearly basis at various locations in our counties. This year 58 individuals took the initial bus driver training course and 165 drivers took the refresher course for a total of 223 bus drivers trained.

## High School Equivalency (HSE/GED) 51 HSE/GED Graduates

The Regional Office has been the authorized administrative office for the General Education Diploma Examinations, commonly known as G.E.D. tests. A change in the statute renamed the process high school equivalency testing (HSE). This program permits people who have dropped out of high school or others who have attained the age of 17 to secure the High School Equivalency Certificate (HSE). The testing of applicants is done by Illinois Valley Community College, in coordination with Cindy Lock, Assessment Center Coordinator. This year 51 participants passed.



## Regional Work-Study Program

The Regional Work-Study program (RWS) has been offering students who have dropped out of area high schools an opportunity to earn a high school diploma since 2010. In the first nine years of the program, 172 students completed the requirements for their high school diploma. Classes are Monday through Friday during the school year at Graves-Hume Public Library in Mendota, as well as the IVCC Ottawa Center. Small classes with plenty of one-on-one assistance create an atmosphere that encourages success. Students can enter the program throughout the school year. LaSalle-Peru Township High School, Mendota Township High School, Ottawa Township High School, Putnam County High School, and Serena High School had at least one student earn a diploma through the RWS program.

### Educator Licensure

The LaSalle, Marshall & Putnam County Regional Office of Education Licensure Department serves teachers and administrators with all aspects of their credential needs. The office has worked to communicate changes from the State Board of Education by conducting individual and staff training. The office provides guidance, documentation, and regularly assists constituents as questions arise. Licensure applications and renewals are completed online. The Regional Office of Education has an available computer workstation that allows license holders to complete requirements. Staff members are available to assist as needed.

# Paraprofessional Training

Paraprofessionals may be considered licensed if they possess one of these options:

- Associate's degree or higher
- 60 semester hours of coursework
- High School Diploma or GED and a score of 460 or higher on the ETS Parapro
- High School Diploma or GED and the following scores on the ACT Workkeys:
  - Applied Mathematics/Applied Math (with a score of 4)
  - Reading for information/Workplace Documents (with a score of 4)
- Paraprofessional licenses are valid for 5 years, and may be renewed with the payment of registration fees.
- If you hold a Paraprofessional License and have a Bachelor's Degree on file, you are qualified to be a substitute teacher.

## Spelling Bee

*The national office is running your SNSB regional bee program for the 2024-2025 year! Here is how it works:*

- 1. Enroll your school in the Bee by 10/31/24 at [spellingbee.com](https://spellingbee.com). The fee is \$185 per school.*
- 2. From October 31st to January 20th the fee is \$199 per school.*
- 3. Register your **school champion** by 01/31/25 by logging into [spellingbee.com](https://spellingbee.com) and selecting School Champion Registration.*
- 4. **Your school champion must take the Regional Qualifier Test** (a 50-item spelling and word meaning test) which opens on February 3, 2025.*
- 5. **The top finishers on the Regional Qualifier Test will advance to the SNSB Regional Bee for Illinois in March 2025.***

## Scholarships

**Over \$2.3 Million Awarded Since Inception**

**\$52,700 Awarded in 2023-2024**

Students may apply for several scholarships offered through the Regional Office of Education. Approximately \$52,700 from the Joseph J. Hohner trust provided 40 scholarships with grants ranging from \$500 to \$3,000 for students from Ottawa area schools for the 2023-2024 school year. Applications are screened by the Regional Superintendent and scholarship committee members as outlined in the will of Dr. Joseph J. Hohner. To date, more than \$2,300,000 has been awarded in scholarships. Other scholarship applications are available from the Regional Office of Education at our website, [roe35.org](http://roe35.org).

## LaSalle/Putnam County Educational Alliance for Special Education (L.E.A.S.E)

The Illinois General Assembly passed House Bill 1407 in 1965, which mandated special education for children with disabilities. Implementation of this legislation became effective July 1, 1969. Prior to July 1, 1969, this Regional Office submitted a plan to meet the requirements of this legislation. Many committees of school administrators and lay citizens aided in formulating the plan, which was approved by the Illinois State Board of Education. Our cooperative, known as L.E.A.S.E., serves 29 school districts, 28 from LaSalle County, and Putnam County District #535.

The Special Education Committee employed Ms. Kathy Fox as its Executive Director of Special Education to oversee operations of the cooperative. The special education programs grew quickly to meet the needs of students with physical and mental disabilities, as well as a variety of other types of disabilities, in LaSalle & Putnam Counties. L.E.A.S.E. works in conjunction with many other agencies in the county to ensure the success of the programs offered.

# Food Cooperative

## 13.97% Savings in Food Costs

The LaSalle County Area Purchasing Cooperative was created during the 1989-90 school year. Eighteen school districts originally joined the cooperative, which bids and orders food and supplies for district-operated cafeterias. Today, 82 school districts representing LaSalle, Bureau, Champaign, Christian, Clark, Cook, DeKalb, Grundy, Iroquois, Kendall, Knox, Lee, Livingston, Macon, Macoupin, Marshall, McLean, Ogle, Peoria, Putnam, Sangamon, Vermillion, Warren, and Woodford counties are members of the co-op. The current total annual expenditures for the cooperative are estimated at 10.7 million dollars. The Regional Office of Education is the administrative agent for this successful program and employs one full-time employee. The cooperative is self-supporting with a minimal fee charged to member districts. The benefits of belonging to the cooperative are:

- Distributor bidding is done for you
- Financial savings
- Networking among fellow members
- Updates on training opportunities
- Access to Kohl Wholesale Dietitian / Menus / Commodity Specialist
- Regular communication on food program requirements
- Assistance complying with requirements

## Duties


Visit and inspect each public school annually.

Supervise school buildings for health and safety.

## District Compliance

The Regional Offices of Education are entrusted with assessing compliance of local school districts and recognized non-public schools in the state of Illinois. This process consists of a systematic review of district documentation and recording compliance with state and federal laws and the Illinois School Code. The resulting designation is reported on the state website and as part of the Illinois Report Card. The compliance process is seen as an opportunity to improve operations and support the programs that deliver quality educational experiences to students.

The Regional Office of Education makes recommendations for the improvement of each school district. Compliance visits for the 2023-2024 school year include: Earlville CUSD #9, Leland CUSD #1, Mendota Township High School #280, Serena CUSD #2, and Wallace #195.



# Finances

## Distribution of Funds

The Evidence-Based Funding for Student Success Act became a law in 2017. This law enacts evidence-based funding (EBF) and changes the way school districts receive the bulk of state funds. EBF, utilized as the primary state education funding system, sends more resources to Illinois' most under-resourced students and is an increased investment in a more equitable system for distributing state resources to school districts, lab schools, and regional programs. The system, which replaced five grant programs, utilizes a hold harmless payment and provides for increases in funding to be delivered to districts most in need. That hold harmless payment, called the Base Funding Minimum, grows annually based on the EBF tier funding (increased funding made available for need-based distribution) and Property Tax Relief Grant amounts paid in the previous year. Increased appropriations in FY 2025 provided an additional \$300 million to be distributed through EBF tiers and up to \$50 million available for distribution through Property Tax Relief Grants.


## 322 students referred for services

Our team, composed of Sam Halm, Rebecca Holzman, Megan Klinfelter, David Lawson, Trevor Witek, Sandra Blanco, and Ginna Campbell were available to assist with matters related to truancy, registration and compliance assistance, homeless assistance, and homeschool resources. The primary focus of the program is to provide intervention and remediation services to truants, chronic truants, potential dropouts, dropouts, and McKinney-Vento-identified students in grades K-12, to increase attendance and academic achievement with a long-term objective of high school graduation. Each school year 300 students are referred for services. Chronic truants may be offered a truancy prevention hearing with the Director of Student Services acting as hearing officer. A contract for attendance, academics, and, oftentimes, counseling is entered into by all parties involved with the student. Chronic truants and/or their parents in need of county court intervention may be referred to county ordinance, juvenile, or criminal court.

## Grants

The Regional Office of Education was funded for the third year of a competitive TAOEP (Truants Alternative and Optional Education Program) grant for the 2023-2024 school year. The TAOEP grant assists with funding the Optional Education Classrooms and helps the ROE to provide services to truants, chronic truants, potential dropouts and dropouts. A total of 322 students received truancy services. The truancy grant was not funded for the 2024-2025 school year.

ROE 35 also received McKinney-Vento funding for the 2023-2024 school year. This grant provides assistance to homeless students. School districts apply to the ROE for funding. Once the request is approved, the school district spends the approved dollars and is then reimbursed for those expenses through the ROE. Requests may be for school supplies, tutoring, excess transportation, clothing, gas cards, food, shoes and other services. There are personal hygiene supplies and various other supplies on hand in the ROE for emergency situations. We also keep a supply of lice kits. Schools should contact their liaison if they have a need. As of this date, 309 students have been identified as McKinney-Vento.



# ROE 35 Academy

## Regional Safe School Program (RSSP)

### Student Eligibility

- Students who are in the Safe School program:
- Students in grades 6 through 12 who are suspension- or expulsion-eligible, expelled due to gross misconduct and who are administratively transferred.
- Provides a system of alternative education programming for disruptive students.
- Meets the particular educational needs of disruptive students more appropriately and individually.

## Truancy (TAEOP)

### Student Eligibility

- Students who are in the TAOEP program:
- Students in grades 6 through 12 who are truants, chronic truants and potential dropouts.
- Students must be enrolled in their HSD (Home School District), and referred by truancy casework in conjunction with the HSD's truancy liaison/school team.
- Provides a modified instructional program and services to students by planning for truancy prevention.

## Alternative Learning Opportunities Programming (ALOP)

### Student Eligibility

- Students who are in the ALOP program:
- Students in grades 6 through 12 who are at risk of academic failure.
- Provides a broader range of academic, behavioral and social/emotional interventions.
- Addresses individual learning styles, career development, and social services that will enable students to successfully complete their education.

## Social Work Service

Our program provided a full-time social worker during the 2023-2024 school year that served students daily with character support intervention. Our program also provided a social work intern from Aurora University.

## 2023-2024 Statistics

- LMP Regional Safe School served 39 students from 14 schools (19 junior high; 20 high school)
- TAOEP Program served 26 students from 8 schools (5 junior high; 21 high school)
- ALOP Program served 23 students from 5 schools (4 junior high; 19 high)
- There were 43 total students enrolled in safe school for the year (23 suspension eligible, Expulsion eligible 9, expelled 7); 26 TAOEP students; and 23 ALOP students
- 2023-2024 attendance for SAFE School, TAOEP, and ALOP: 72.6 % junior high: 72.5%; for high school: 73.4%
- We will start the 24-25 school year with 8 Safe School high school students, 10 Safe School junior high students, and 9 TAOEP high school students, 7 TAOEP junior high students; 11 ALOP High school students; 0 ALOP junior high student
- Ten eighth-grade students graduated; nine high school students graduated
- Since 1997, we have served 1974 students

## College/Career Development

A total of 15 students participated in Career Tech Education; 6 students actively worked. Business Employment Skills Team (BEST) presented from local agencies including: State Farm Insurance, YMCA, Carus Chemical, Riverfront Restaurant, Carpenters Union, and Illinois Valley Contractors Association. Team members presented information on career exploration, goal setting, job searching, and professional responsibilities.
