Comment: Kathy Steinz, Nursing Home Administrator, addressed the committee with a request to raise the PRN hourly rate of pay from \$33.74 to \$40.00; This request was previously approved by the Nursing Home committee and forwarded to this committee today; It was explained that these are parttime, no benefit positions; They will be looking to fill up to 4 positions to alleviate the hiring of agency RNs to cover when staffing is short; that expense is double the requested hourly rate, average is \$78-84/hour for each agency nurse scheduled. The committee asked clarifying questions, the Nursing Home Administrator provided response.
