

2010-2011 LASALLE COUNTY ANNUAL TAX LEVY ORDINANCE

We, the Finance Committee of LaSalle County Board, LaSalle County Illinois, find that the amount appropriated for said period of December 1, 2010 through November 30, 2011, by the LaSalle County Budget and Appropriations Ordinance heretofore made and adopted by the County Board of LaSalle County of Illinois is in the amount of **\$ 70,154,139**, for the several objects and purposes specified in 2010-2011 Budget and Appropriation Ordinance.

Therefore, it will be necessary to raise, by taxation, the total of **\$ 25,116,920** for all corporate purposes of said County, including General County Purposes, Detention Home, Illinois Municipal Retirement Fund, Social Security Fund, County Highway Maintenance and Upkeep Fund, Special Tax Match, as is authorized by 605 ILCS 5/5-603 Bridges constructed by the County on Township and County Line Roads, LaSalle County Mental Health "708" Board, as is authorized by a referendum held under the provisions of 405 ILCS 20/4, LaSalle County Nursing Home, as is authorized by a referendum held under the provisions of 55 ILCS 5/5-21001, Insurance, Veterans Assistance Commission and LaSalle County Health Department, as provided by 70 ILCS 905/21 et. seq. and we recommend said levy ordinance for approval for the general and specific purposes set forth herein on Exhibit "A" attached hereto and incorporated herein.

NOW THEREFORE, BE IT ORDAINED by the County of LaSalle, acting by and through the LaSalle County Board that there is hereby levied upon all taxable property in the County of LaSalle, State of Illinois, a direct tax for the period of December 1, 2010 to November 30, 2011 for the general purposes set forth herein and as more specifically set forth on Exhibit "A" attached hereto and incorporate herein as follows:

The sum of **\$ 6,495,505** for corporate purposes of LaSalle County to produce the sum of **\$ 26,222,019**.

Also, the further and additional sum of **\$ 389,712** for **Detention Home** to produce the sum of **\$ 1,419,332**.

Also, the further and additional sum of **\$ 3,537,800** for the **Illinois Municipal Retirement Fund** to produce the sum of **\$ 3,537,800**.

Also, the further and additional sum of **\$ 2,016,003** for **Social Security** to produce the sum of **\$ 2,016,300**.

Also, the further and additional sum of **\$ 2,598,082** for the **County Highway Fund** to maintain the roads of LaSalle County and also for the purpose of New Machinery, Repairs to Road Machinery, Machine Rental, and Maintenance of County Roads and Buildings, County Highway to produce the sum of **\$4,354,119**.

Also, the further and additional sum of **\$ 1,299,041**, for the County's share of **Bridges constructed by the County on Township and County Line Road**, as is authorized by 605 ILCS 5/5-602, to produce the sum of **\$ 3,127,001** said sum of **\$ 1,365,000** broken down as follows:

Also, the further and additional sum of **\$ 1,299,041**, for the County's share of **Special Matching Tax** constructed by the County, as is authorized by 605 ILCS 5/5-603; to produce the sum of **\$ 1,900,010**.

Also, the further and additional sum of **\$ 2,452,590** for the **LaSalle County Mental Health "708" Board** to produce the sum of **\$ 2,452,951**.

Also, the further and additional sum of **\$ 1,478.309** for the **LaSalle County Nursing Home** to produce the sum of **\$ 6,659,036**.

Also, the further and additional sum of **\$ 2,214,542**, for the **Insurance Fund**, as provided for in 745 ILCS 10/9-107 to produce the sum of **\$ 2,607,843**.

Also, the further and additional sum of **\$ 314,368** for the **LaSalle County Veterans Assistance Commission**, to produce the sum of **\$ 314,368**.

Also, the further and additional sum of **\$ 1,021,926** for the **LaSalle County Health Department** to produce the sum of **\$ 3,300,935**.

BE IT ORDAINED AND ORDERED that the County Clerk of said County of LaSalle, State of Illinois, is hereby directed to extend the tax aforesaid to raise respective amount above set forth.
