Acknowledgement of Beer Garden Permit

All applicants and renewals must Read, Sign and Return this form with liquor application; stating that they understand the changes on the following section marked "*LaSalle County Rules & Regulating of the Retail Sale and Consumptions of Alcoholic Liquors in the Unincorporated Areas in the County of LaSalle, Illinois*" (*Ordinance #16-122 dated 9-12-16 Amended Ordinance #17-158*) Manual, **Section Two b) License Required** and **Section Eighteen: Hours of Sale**

These changes have been approved by the LaSalle County License Committee and the LaSalle County Board and are effective immediately.

All applicants applying for Beer Garden Permit or renewing a Beer Garden Permit must be in compliance with the requirements before having a Beer Garden license issued. If upon discovering non-compliance after the license has been issued will result in the Cancellation of Beer Garden Permit for that establishment. Fines may be implemented if this establishment is found to be operating without Beer Garden Permit or in non-compliance to Ordinance #16-122 date 9-12-16 *Amended Ordinance #17-158*.

I, the undersigned applicant or authorized agent therefore, swear or affirm that:

- I have read completely and understand "*LaSalle County Rules & Regulating of the Retail Sale and Consumptions of Alcoholic Liquors in the Unincorporated Areas in the County of LaSalle, Illinois*" (*Ordinance #16-122 dated 9-12-16*) **Manual Section Two b) License Required** and **Section Eighteen: Hours of Sale**
- That the application for Beer Garden Permit for _____ (establishment name or dba) **is in complete compliance** with "*LaSalle County Rules & Regulating of the Retail Sale and Consumptions of Alcoholic Liquors in the Unincorporated Areas in the County of LaSalle, Illinois*" (*Ordinance #16-122 dated 9-12-16 Amended Ordinance #17-158*) **Manual Section Two b) License Required 1) through 2) i through vii, at the time this form and the other renewal forms is returned for processing**
- That the application for Beer Garden Permit for _____ (establishment name or dba) will only operate the Beer Garden as *Ordinance #16-122 Amended Ordinance #17-158* specifies in **Section Two b) License Required 2) i through vii and Section Eighteen: Hours of Sale** (**NOTE: hours are different on Beer Garden permits than on Establishments**)
- If above establishment or dba is found **NOT to be in compliance**, the LaSalle County Liquor Commissioners will revoke the Beer Garden Permit. Any future occurrences of violation may have a fine implemented against above stated establishment or dba.
- Operating a Beer Garden without Permit is illegal.
