**DRUG COURT PROBATION ORDER**

The Court, having considered the nature and circumstances of the Defendant's offense, and the history, character and condition of the Defendant, has determined that the public and the Defendant would be best served by a sentence of probation as approved by the LaSalle County Drug Court team. Accordingly, the defendant is hereby sentenced to a period of probation for \_\_\_\_\_ months from this date, subject to the following conditions, which are that the defendant must:

1. Not violate any criminal statute of any jurisdiction.
2. Report in whatever fashion as directed in writing by a Probation Officer to the LaSalle County Court Services Department, including a requirement that Defendant may be required to report as often as daily in person as early as 8:00 a.m.
3. Refrain from possessing a firearm or other dangerous weapon.
4. Not leave the State of Illinois without the permission of the Court.
5. Allow a Probation Officer and Law Enforcement to visit the Defendant's residence, place of employment or any other place that the Defendant may be, in the sole judgment of the Probation Officer.
6. Unless there is an emergency, not change residence or employment without prior written permission of a Probation Officer and reside where directed in writing by a Probation Officer and/or Presiding Judge.
7. The defendant will abide by any curfew imposed by the drug court team in writing and is subject to electronic monitoring/GPS as directed. A smart phone location monitoring application may also be utilized if applicable.
8. Not be present at any place, business, building, park, apartment, residence, or other specified location of whatever designation at which place or places the Defendant's presence has been prohibited in writing by a Probation Officer, or stated by the Court to the Defendant in open court.

9. The defendant will have no contact with \_\_\_\_\_ or the property of \_\_\_\_\_.
10. Cooperate with and maintain truthful, accurate, and appropriate communications with all officers of the Court Services Department and any treatment provider or counselor and promptly, fully, and completely obey all orders given by any Probation Officer.
11. Any order or directive given in writing by a Probation Officer to the Defendant may be changed or altered in writing only. All claims by a Defendant that she/he had oral permission from a Probation Officer to change alter, or not follow an order or directive given to him in writing by a Probation Officer will be rejected by the Court.
12. The Defendant shall appear at the LaSalle County Courthouse in a Courtroom to be announced on the day designated for Drug Court, unless otherwise directed by the Court for purposes of reviewing the Defendant's progress and compliance with the terms of the sentence.
13. That the Defendant is prohibited from using alcohol, cannabis, or any controlled substances except those prescribed by a licensed physician and only in amounts prescribed. The Defendant must refrain from contact with persons who use any of these substances and all claims that a banned substance is in the Defendant's bodily system from any sort of second hand smoke will be rejected. Whenever directed by a Probation Officer, and/or the Court, submit a breath, urine or blood specimen or all such specimens for analysis to be determined therein the presence of drugs or alcohol. The presence in the Defendant's breath, urine, or blood of cannabis, alcohol, any other controlled substance or other illegal drug is, by itself, a violation of these probationary conditions. A reading of any scientific test performed on the Defendant's breath, urine or blood for any of the aforesaid substances which shows the presence of any of these substances in the Defendant's bodily systems is a sufficient basis to find a violation of these conditions.
14. Cooperate with all referrals as directed by the Court, and the LaSalle County Court Services Department.
15. Cooperate with any and all treatment plan and counseling requirements made by the Court, including but not limited to any type of sobriety based self-help group meetings and individual and or group counseling sessions.
16. Cooperate with and initiate any directive to seek and/or maintain employment, complete a job training program, obtain a G.E.D. or complete any other educational or training program when advised by the Court, or the LaSalle County Court Services Department.
17. Authorize the full exchange of information including evaluations, drug test results and treatment information between the LaSalle County Court Services Department, and the Drug Court team that is necessary to show progress in the Drug Court Program.

18. Immediately comply with any and all sanctions imposed by the Court and all Orders Modifying this Probation including but not limited to an incarceration sanction, home detention and public service work.

The Defendant is further ordered to comply with the following additional conditions as marked:

- ☐ 19. Perform \_\_\_\_\_ hours of Public Service Work when and where directed by a Probation Officer, and or the court. Transportation is not provided. P.S.W. hours are ordered to be completed within the next \_\_\_\_\_ months.
- ☐ 20. You will pay fines, fees and costs based on ability to pay. If applicable, a pay plan will be implemented which will not prohibit program entry, phase advancement or graduation.
- ☐ 21. The Defendant shall undergo medical testing pursuant to 630 ILCS 5/5-5-3(g).
- ☐ 22. That the Defendant comply with the requirements of the Sex Offender Registration act (730 ILCS 150/1 et seq.) within 30 days.
- ☐ 23. That the Defendant refrain from entering the area outlined in the attached map, provided to the Defendant in open court.
- ☐ 24. Submit specimens of blood, saliva or tissue to the Illinois Department of State Police within 45 days at a collection site designated by the LaSalle County Court Services Department in accordance with 730 ILCS 5/5-4-3 and pay a \$250.00 DNA analysis fee.

**IT IS A FURTHER ORDER OF THE COURT**, and the Defendant is hereby advised, that the Court may at any time during the period of probation revoke or modify any conditions of probation or reduce the period of probation or may discharge the Defendant from probation.

The Defendant is subject to arrest for any violation of any condition of this probation. If probation is revoked, the Court may impose any sentence authorized by law.
